





## MARKET RESEARCH SUMMARY RESULTS

Between the 26th of February 2024 and the 14th March 2024, the International Trade Council embarked on a comprehensive market survey, targeting a broad spectrum of companies to assess the anticipated value and applicability of the forthcoming ADAMftd tool. 






Above: Respondents by Job Title


### **ACCEPTANCE BY DECISION-MAKERS**


## DEMAND TO KNOW MARKET PRICE & DEMAND OF PRODUCTS


## SIMPLIFYING GLOBAL TRADE COSTS WITH AUTOMATION
